

## **Community Foundation Awards Nearly a Quarter-Million Dollars in 2015 From Unrestricted Funds**

In 2015, the Wabash Valley Community Foundation, together with its affiliates, the Clay County Community Foundation and the Sullivan County Community Foundation, awarded \$249,086 to 43 nonprofits in Clay, Sullivan and Vigo counties.
