## “BLESSED FOR ANOTHER DAY” HONORING A FRIEND’S LEGACY

Matt Luecking was the type of individual who never met a stranger; he always had a smile on his face, a kind word for everyone he met and he would always exclaim how he was “Blessed for Another Day.”

In late October 2016, Matt lost his life in a senseless act of violence. As his friends struggled to cope with the circumstances surrounding his death, there was also a sense of urgency to ensure that Matt’s legacy would live on in perpetuity.

"We were so shocked at this senseless loss of life and wanted to do something to remember our friend," said Susan Turner, co-creator of the "Blessed for Another Day" – Matt Luecking Memorial Endowment Fund. "We knew we wanted to do something, but what? We decided to hold a meeting at the Terre Haute Chamber of Commerce [where Matt was an Ambassador] for those who wanted to help come up with a way to honor him. "

It was during this meeting that the group of friends started sharing ideas of how they could fulfill their common desire to do something that would reflect Matt's contributions to the community he loved. Though they entertained various ideas, Rachel Leslie ultimately suggested creating an endowment fund within the Wabash Valley Community Foundation so that his impact would be forever.

"Once we started talking, it made perfect sense to choose the Community Foundation," said Turner. "He loved Terre Haute – he wasn't from here, but he made his life here. We wanted him to continue to have that influence in the years to come." Thus, the "Blessed for Another Day" – Matt Luecking Memorial Endowment Fund was established within the Community Foundation. This fund will provide grants to the Vigo County Education Foundation, Terre Haute Parks Department and Terre Haute Children's Museum on a rotating basis.

Jamie McDowell, another one of the fund's co-creators, explained the selected organizations represent a few of the areas Matt was passionate about. "Matt and I talked in-depth about so many things – from our love of sports to radio and music to supporting a vibrant downtown and how important the Terre Haute Children's Museum is to that effort. Plus, it was his favorite place to bring his niece and nephew!"

Though several months have passed since the fund was established, Matt's friends continue to be amazed by the contributions received. Each gift, no matter the size, is meaningful and a testament to how many people Matt touched throughout the course of his life.

"Matt was a connector," explained Turner. "He knew everybody. Those he surrounded himself with are positive and life affirming, and that is how we want people to remember him. He was full of life and love for Terre Haute and the community."

Because of the fund established within the Community Foundation, Matt's legacy will live on and the community he loved will continue to be "Blessed for Another Day."

# SCHOLARSHIP DEADLINE FOR 2018-2019 ACADEMIC YEAR FAST APPROACHING

Are you considering applying for a scholarship within the Wabash Valley Community Foundation, but aren't sure where to begin? We suggest you spend some time thinking about the essay portion of your application as it is an integral part of the application process. Be original, be sincere and write it yourself! To help get you started, below are the top three items to list in your scholarship essay.

## 1. Career Aspirations

- How did you arrive at your decision? Tell a story to help the reader learn more about you.
- How do your plans relate to your educational and career objectives?
- How do you plan to use your career to contribute to the community? Tell the reader why you deserve this scholarship.

## 2. Activities Outside of the Classroom

- You have listed your extracurricular and community activities in your application, now elaborate in your essay. Did you hold a part-time job while attending school, or volunteer at an organization?
- Why did you choose these activities? Did these activities enrich your academic, social or personal life?
- How did these activities prepare you for your academic career and beyond?

## 3. Distinguish Yourself from other Applicants

- Did you receive a prestigious award while in school? Write about it! Your scholarship application and accompanying essay is essentially your sales pitch. If you don't write about it, the reader won't have a chance to be impressed. This is one of those times where bragging about yourself is encouraged!
- Do you have any skills, talents or passions? Applying for scholarships is a highly competitive process, so emphasize things that demonstrate your ability to lead, take initiative, persist and care for your community!

Remember, hundreds of individuals have made a difference by endowing scholarships for students such as yourself. Higher education costs are on the rise, but scholarships can make it easier and more affordable to attend college. The application will open on **July 12, 2017 at [wvcf.com/scholar\\_apply.html](http://wvcf.com/scholar_apply.html)** and will close promptly at **2:00 p.m. Wednesday, August 23, 2017**. We strongly encourage you to beat the application deadlines and apply as soon as possible!
