NEARLY \$90,000 AWARDED FOR RAPID RESPONSE GRANTS

When the first COVID-19 positive case was reported in our area in mid-March, the Wabash Valley Community Foundation acted swiftly to provide immediate assistance to entities on the front lines helping our communities through the COVID-19 pandemic. Citing the unprecedented and unforeseen challenges resulting from the pandemic, the Community Foundation implemented a Rapid Response grant process available for eligible entities in Clay, Sullivan and Vigo counties.

Available in increments of up to \$5,000, the Rapid Response grants provided immediate support to hospitals, federally qualified health centers, city and/or county law enforcement, EMS, county health departments, emergency management offices and professional and/or volunteer fire departments to carry out their work for the benefit of our communities. Community Foundation staff expedited the process to ensure entities had funding in hand within one week of their application,

with most receiving funding within 48 hours of their request.

To date, the Community Foundation has awarded 19 Rapid Response grants totaling \$89,104.33 to immediately address a wide array of needs arising from the pandemic such as health and human services, emergency equipment and more. As the pandemic continues to unfold and affect our communities, we will routinely monitor and address the need for continued support.

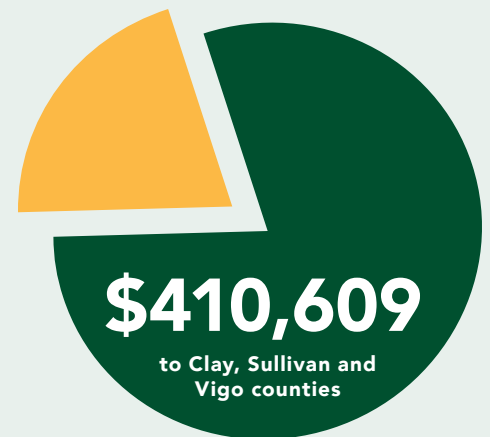
UW/CF COVID-19 RELIEF FUND GRANTS OVER \$500,000

For nearly thirty years, the Community Foundation has provided grants to support vital projects and programs in Clay, Sullivan and Vigo counties. We have worked together with philanthropic partners to support education, improve health care, advance quality of life efforts and respond to emerging challenges in the communities we serve.

In early March, the Community Foundation and United Way coordinated a response to support immediate economic stability and basic needs in light of the anticipated impact of the COVID-19 pandemic. Through the establishment of the Wabash Valley COVID-19 Relief Fund, the Community Foundation and United Way have quickly and effectively granted resources to community-based organizations best positioned to meet the emerging needs resulting from the pandemic.

Serving the areas of Clay, Parke, Sullivan, Vermillion and Vigo counties in Indiana and Clark County in Illinois, grants have been awarded to organizations such as healthcare, education, business and nonprofits directly assisting residents most affected by the emerging health, economic and social impacts of COVID-19.

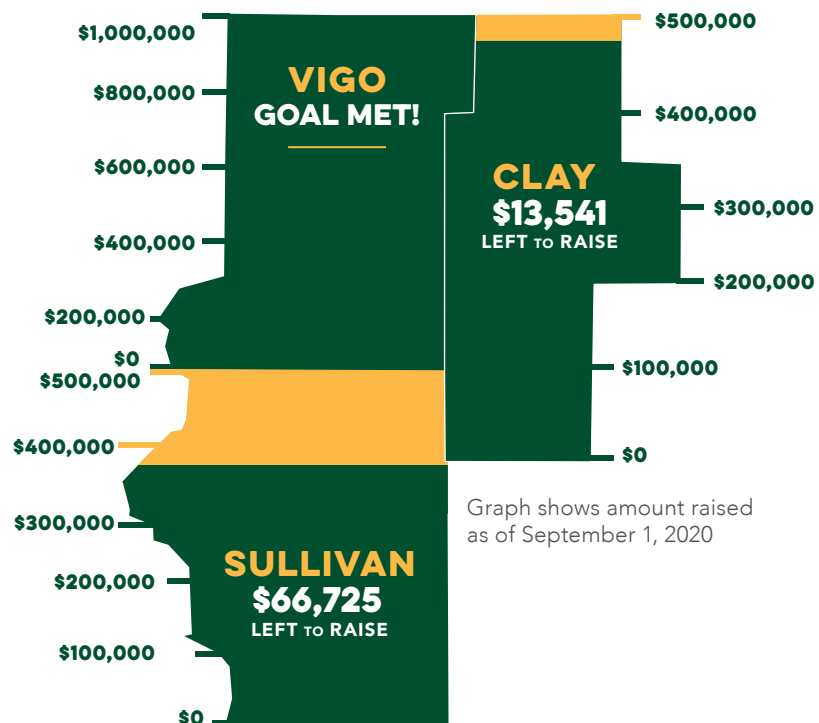
When possible, unrestricted endowment funds are also used to facilitate emergency responses to community challenges. Thanks to unrestricted endowment funds, the Community Foundation has granted nearly \$90,000 to sustain and develop vital community services and equipment necessary for entities serving on the front lines of the unfolding pandemic.

As we work to improve and enhance the quality of life, contributions to unrestricted endowment funds are of vital importance to the communities we serve. These funds have not only provided funding for community improvements year after year, but have allowed us to rapidly provide flexible resources to nonprofit organizations who are working on the front lines, engaging and supporting individuals impacted by COVID-19, as well as to address the broader ramifications of the pandemic.

Our communities need unrestricted support now more than ever to continue serving residents, and the **\$2-for-\$1**

match offered by Lilly Endowment Inc. ensures community support is magnified in this time of need. There is **only** \$13,541 left to raise in Clay County and \$66,725 left in Sullivan County; Vigo County has already met the match. Once the match is met in all three counties, the Community Foundation will receive \$2 million in additional unrestricted funds to be endowed for the benefit of residents in Clay, Sullivan and Vigo counties forever.
