The legacy of a former Terre Haute resident will live on for generations thanks to an endowment fund established through a bequest.

When Mrs. Swango passed away in April of 2019, she left provisions in her will to create the J. Morton & June K. Swango Fund for the benefit of four local organizations. As she was an ardent supporter of natural history and a champion for the preservation of natural lands, the Fund will continue her legacy and provide annual support to the Terre Haute Parks and Recreation Department, TREES Inc., Vigo County Historical Society and Vigo County Parks and Recreation Department.

The Community Foundation recently made the first distributions from the

Fund – granting a total of \$48,758 for the benefit of the four designated Vigo County organizations.

"It is thanks to the foresight of community-minded individuals that allows us to continue to enrich lives in Clay, Sullivan and Vigo counties," explained Beth Tevlin, Executive Director of the Wabash Valley Community Foundation. "As charitable stewards for our community's philanthropic endowments, we are grateful for Mrs. Swango's generosity and look forward to honoring her intent in perpetuity."
